On behalf of the Board of Directors, this letter is to notify you of the upcoming Coventry Homeowners Association Annual Meeting, which will be held on Tuesday, November 13, 2018. The Annual Meeting will begin at 7:00 PM and sign in and pizza will be served starting at 6:30 pm. Location: McGraw Elementary School, Flex Room 401 located at 4800 Hinsdale Drive, Fort Collins, CO 80526.

Coventry Homeowners Association is a Common Interest Community; the Declarations were originally recorded June 02, 1995; Reception # 95031319. The fiscal year for Coventry Homeowners Association is January through December. Coventry HOA is managed by Onsite Management, 2121 Midpoint Drive, suite 302, Fort Collins, CO 80525. During the 2018 fiscal year, homes were assessed \$550.00 annually. In 2019 HOA dues will stay the same, however, there will be a special assessment for a new fence in the amount of \$489.00 per homeowner (payable in installments) and those statements will be mailed separately. The timely payment of dues and special assessments assures the association is maintaining good financial status for the benefit of all homeowners. Please remember to make your checks payable to Coventry HOA and mail to Onsite. Your annual dues payment should be in the office of Onsite, before the due date of January 1, 2019. A late fee of \$50.00 is incurred 10 days after the due date. Trash service will be suspended for any Annual dues not paid by March 1, 2019 (unless a payment plan has been set up).

Call to order/Roll call / Establish Quorum – Board President Chris Berger called the meeting to order at 7:03 pm. All board members were present: Chris Berger, Robert Kaczanowski, Rocky Knutson, Chad Schneider and Melanie Stalzer. Michelle Bermejo attended for Onsite Property Management. There being 30 persons present via proxy or person, a quorum was established.

Approval of the 2016 Annual Meeting Minutes – Robert Kaczanowski motioned to approve the 2016 annual meeting minutes and was seconded by Chris Berger, motion passed unanimously.

.Financial Review for 2017 - Balance as of 10/31/17:

Reserve: \$20,052.60

Total: \$31,992.59

Ratify 2018 Budget – The annual dues were increased by \$50.00 to \$550.00 for 2019. The increase is necessary for landscape improvements for 2018 and to cover the increase in trash service. With no rejection to the budget, it is ratified into the association's records.

Election of New Board Members – Two positions are open for election, no one volunteered or no one was nominated from the floor. The current board will stay in place via acclimation.

Homeowner Forum – A homeowner expressed concern about the damage to the trees in the cattail area. Trees will be monitored for health and possible removal in the spring. A homeowner requested that new landscaping improvements be considered for the corner of McGraw Drive. A homeowner requested that the cattail limbs removed from the May storm be removed. All homeowners concerns were addressed.

Meeting Adjournment - There being no further business to conduct the meeting adjourned at 8:03 pm.
